That started my active participation in some high percentage of the BMG's output over the past decade. Prior to joining the BMG, as noted above, I had been involved individually corresponding and speaking with the OECD about the BEPS project's direction. Despite this prior involvement, I know that Sol, in getting me into the BMG for which he was the coordinator, provided me with the inspiration, guidance, and structure that I needed to be an active contributing participant throughout the entire past decade of the project, something that otherwise would never have happened. I'm sure that this is also true for some of the others that Sol inspired to join the BMG.

Has involvement in the BMG been free of pain and suffering? Think of the innumerable documents and public consultations that the OECD and the Inclusive Framework have issued, some of which have been massive. These have had to be read in detail...sometimes multiple times. Terrible. Sol has been immersed in both the big picture and all the detail throughout. Along with participating BMG members, Sol has consistently and tirelessly been at the centre of things throughout this decade discussing BMG positions and writing and reviewing the many submissions.
